Committee Roundtable

- Leonard Sledge commented on the good synergy between the City and new organizations coming to Virginia including LEGO, Plenty, and HQ Hotel.
- Amy Parkhurst shared that the Hampton Roads Alliance hired consultant to evaluate sites specifically for Data Centers and whether it was important to attact Data Centers to the region.

- Greg Hitchin mentioned that two sites are being developed for specific projects. He also reminded the Advisory Committee and VEDP of the 2025 opening of the Virginia Museum of National History Waynesboro campus.

Committee Elections

- -Emily Lampkin moved to nominate Leonard Sledge as Vice Chair for two consecutive years. Amy Parkhurst seconded the motion and was approved unanimously by voice vote of the members present.

Wrap-Up and Ideas for Future Meetings

- -Leonard Sledge reiterated the desire for some meetings to be away from the VEDP office so the Committee can see sites and have a greater understanding of programs. Lori Melancon informed the Committee that a meeting may be in Virginia Beach at the same time of the new Consultant Conference in May 2023.
- -Leonard Sledge suggested a post mortum of why an organization chose Virginia to establish it's business. Both Leonard Sledge and Beth Doughy would prefer a representative from the company to attend the next meeting to present the reasons and answer specific questions.
- -Beth Doughy asked that Research present on recent updates in the near future.
- -Vince Barnett announced the partners from Europe and Asia will be in Virginia January 9-13 2023 and perhaps could host an event for regional partners and the Committee to meet VEDP partners from over seas.
